- 3. Thanked Council Member Lee for presiding over the previous meeting as Mayor ProTem.
- 4. Thanked the Chamber for launching their campaign Two, Rivers One Heart.
- 5. Thanked Council Member Gillespie and her husband Barry for decorating the planter boxes downtown for fall.
- 6. Presented figures from Municipal Court.
- 7. Reported he has secured donated labor to run wiring at Fowler Park and the cost for materials will be \$3000.00 to \$3500.00.
- 8. Reported homecoming banners for the light poles downtown have been ordered.

Council Member Gillespie moved to approve running wiring at Fowler Park. The motion was seconded by Council Member Bixby and was approved by a six (6) to zero (0) vote with Mayor Hayes abstaining.

Council Member Gillespie stated she would like to see the camp sites at the park updated. Council Member Bixby stated he would like to see additional camp sites added.

City Clerk Johnson reported she has received a request to close the street between 101 S. Liveoak to 308 S. Liveoak on October 29th from 5:00 p.m. until 8:00 p.m. for a public trick-ortreat event. Council Member Coleman moved to authorize the closing of the street. The motion was seconded by Council Member Bixby and was approved by a six (6) to zero (0) vote with Mayor Hayes abstaining.

Attorney Gray reported he has received an agreement for housing inmates at the county jail. He stated under the agreement, the cost to house inmates will double from \$20 per day to \$40 per day with a \$20 payment to the County Commission and a \$20 payment to the sheriff. Council expressed concerns over the increase.

Council Member Coleman moved to approve the new agreement. The motion was seconded by Council Member Bixby and was approved by a six (6) to zero (0) vote with Mayor Hayes abstaining.

Building Inspector Wuest reported on tiny homes and presented plans for a proposed home to be located in town.

Street and Sanitation Superintendent Brewer gave a project and equipment report and reviewed the holiday garbage schedule for the Columbus Day holiday.

Police Chief Mock gave an activity report and reported on training and monthly meetings for the department.

Code Enforcement Officer Owens reported letters have been sent to seven properties under the new dangerous buildings ordinance. He stated he is working on the next list of houses for Council's review. Council Member Coleman's report included the following:

- 1. Asked if large trucks could be restricted on Madison and Lincoln Streets.
- 2. Reported on constituent complaints regarding dogs on Purvis Avenue and Trinity Street.
- 3. Asked if a decision has been made on the type of speed bumps to be used
- 4. Inquired about a burn ordinance.
- 5. Requested the intersection at College Avenue and Iris Street be made into a four-way-stop.
- 6. Inquired about an ordinance regulating golf carts on City streets.

Council Member Fountain requested the property on the left side of the road going to the Junction be cleaned up.

Council Member Coleman stated he has received complaints on dogs going to the Junction.

Mayor Hayes expressed his apperception to Council Member Fountain's church for sponsoring an appreciation dinner for emergency responders.

Council Member Bixby informed Council that he has been contacted by homeowners on Beck Place regarding paving their road. He stated they have an estimated cost and are willing to contribute funding towards the project. He stated he will get more details and present at a future meeting.

Council Member Gillespie reported Police Chief Mock will be discussing homecoming activities with grades 10, 11 and 12.

Council Member McCoy asked if recreation department football games could be scheduled later in the afternoon due to heat. He stated several individuals had gotten sick from the heat.

Council Member Lee thanked everyone for their prayers for his family during recent illnesses. He inquired about the opening date for the new seafood restaurant.

David Swinton inquired about insurance for water leakage and was informed he would need to contact the Water Works and Sewer Board regarding the matter. He also stated he has brought the garbage can from his brother's residence to his house and it has been picked up twice. He also inquired about setbacks on Jim Bob Kelly Road.

Council Member Lee moved to adopt a resolution authorizing an application for grant assistance from the CARES Act Community Development Block Grant Coronavirus (CDBG-CV) Grant Fund and committing matching funds in the amount of \$341,775.00. The motion was seconded by Council Member Fountain and was approved by a six (6) to zero (0) vote with Mayor Hayes abstaining.

City Clerk Johnson explained that currently her department shares an employee with the Police Chief. The employee is assigned 20 hours as custodian and 20 hours for animal control. She further explained there have been no applications for the van driver for the senior citizens department and because this employee has a CDL license he has been filling this position during the time he needs to be performing custodial duties. She requested the current employee be transferred to the senior citizens department as van driver or assigned as full time for the police/animal control departments and then she could hire a custodian. Chief Mock stated that he could use the employee during the 20 hours for community service projects.

Council Member Tidwell moved to amend the manning document to add 20 hours to the police/animal control department and amend the budget as necessary. The motion was seconded by Council Member Gillespie and was approved by a six (6) to zero (0) vote with Mayor Hayes abstaining.

A work session was scheduled for October 27th at 4:30 p.m.

Mayor Hayes gave the following report:

1. The grant to repair the trestle from WRC&D has been approved for \$8,000.00.

- 2. The City will receive additional covid funds for the airport and he proposed constructing a bathroom for use by pilots.
- 3. A meeting was held on the soccer project with the engineer.
- 4. Homecoming was successful.

City Attorney Gray reported on City Court dates, a meeting with GA Foods and continued issues with the cable company franchise. He reported on the next steps in the abatement of unsafe structures under the new ordinance.

Mayor Hayes also commented on the meeting with GA Foods and reported two state officials have visited and monitored the food being delivered to the senior center.

Street and Sanitation Superintendent Allen Brewer gave an update on projects.

Police Chief Pepper Mock reported on a meeting with various officials and organizations regarding mental health issues. He also reported on activity relating to homecoming.

Chamber President Shelby Danley thanked the Mayor and Council for their support. She presented numbers for visitors during the weekend of Rock-a-Dock.

Council Member Fountain reported potholes in his district.

Council Member Lee's report contained the following:

- 1. A request for speed bumps on S. Morris Street and E Promenade Avenue.
- 2. A request for an update on the status of the tree removal in the ditch near the church on N. Morris Street.
- 3. Potholes on Railroad Avenue and Westville Avenue

He requested that part of his report time be allotted to business owners in his district. Mrs. Serina Fleming, owner of the Vintage Room questioned City policy and ordinances regarding noise as it related to homecoming activities.

Council Member Gillespie inquired about a start date for beginning to decorate downtown, particularly the planter boxes.

Council Member Coleman's report contained the following:


- 1. Inquired about closing streets for events

The Geneva City Council met in regular session on November 1, 2021, at 6:00 p.m. in the Council room at City Hall. Council Member Lee arrived at 6:30 p.m. and was present for the remainder of the meeting. None were absent. Also present were City Clerk/Treasurer Lisa Johnson, City Attorney Jeff Gray, and various department heads and employees.

Mayor Hayes called the meeting to order.

Council Member Fountain gave the invocation and Mayor Hayes led the Pledge of Allegiance.

Council Member Coleman moved to dispense with the reading and approve the minutes of October 18 and 27, 2021. The motion was seconded by Council Member Gillespie and was approved by a four (4) to zero (0) vote with Mayor Hayes and Council Members Tidwell and Bixby abstaining.

Mayor Hayes presented the Mayor's Certificate of Appreciation to Truett Gilmore for volunteering and cleaning up at Robert Fowler Park.

Council discussed issues with the food being served at the Senior Center and the contract with SARCOA. They discussed not renewing the contract and hiring a cook and preparing their own meals.

Council Member Lee arrived at 6:30 p.m. during discussion of the SARCOA contract.

City Clerk Johnson informed Council she is having trouble getting individuals to apply for the custodian position and the Senior Citizens Director and Librarian have had issues with receiving applications for part-time aide positions. She asked Council to consider setting the pay for part-time custodian and aide positions at \$8.50 per hour.

Council Member Coleman moved to amend the manning document to increase the starting pay of the part-time custodian and part-time aides to \$8.50 per hour. The motion was second by Council Member Fountain and was approved by a seven (7) to zero (0) vote with Mayor Hayes abstaining.

Council discussed the current per-diem rate. Council Member Lee moved to increase the reimbursable per-diem rate at a maximum of \$60.00 per day for meetings and training when meals are not already provided as a part of a conference, etc. and upon submittal of a receipt. The motion was seconded by Council Member Bixby and was approved by a seven (7) to zero (0) vote with Mayor Hayes abstaining.

Council Member Tidwell moved to approve an application for the Geneva Festival on the Rivers Committee to hold a parade on April 29, 2022. The motion was seconded by Council Member Bixby and was approved by a seven (7) to zero (0) vote with Mayor Hayes abstaining.

Council Member Tidwell moved to approve the use of Fowler Park and approve an event request for the Geneva Festival on the Rivers Committee to hold its annual festival on April 29, through May 1, 2022. The motion was seconded by Council Member Bixby and was approved by a seven (7) to zero (0) vote with Mayor Hayes abstaining.

Mayor Hayes stated that it was this Council's first year anniversary. He expressed his appreciation to the Council and city employees for working together for the first year of this term. He stated he felt the City was on a good and positive path. He commended all involved with the Halloween functions around the city and reported on the large crowd at the Junction. Mayor Hayes reported on the orientation for the Economic Development Academy and the Christmas planning meeting.

City Clerk Johnson reported on applying for coronavirus funding for the Rescue Squad, preparation for the upcoming audit and time clock project.

City Attorney Gray stated he has enjoyed his first year as City Attorney. He complimented all of the Halloween functions around the city. He also informed Council he is reviewing a new software program for municipal court.

Street and Sanitation Superintendent Brewer reported the Ridgecrest drainage repair is complete, the new three-way and four-way stop signs are up and the delay in deliveries for crusher run gravel.

Captain McDuffie gave the police report in absence of Chief Mock. He gave an activity report, grand jury report, and firing range training report.

Code Enforcement Officer Owens gave a report on the number of violations issued and their status.

Council Member Coleman inquired about painting the road at stop intersections. He inquired about a possible four-way stop at Lincoln Street and Pine Avenue and the status of speed bumps. He inquired about the status of the Boys and Girls Club and reported complaints on speeding on Sunflower Street.

Council Member Gillespie reported the Christmas committee would like to show the movie the Polar Express as a Christmas activity. She inquired about licensing the movie. City Clerk Johnson stated she would handle the licensing and expense the cost to the holiday budget if there were no objections.

He requested approval to purchase spare batteries for SCBA equipment at a cost of \$4,215.00 and an emergency generator for \$5,727.00 out of the ARPA funds received. He requested the City assist in the cost of in stallion of the generator and change out of lights at the station to LEDs. He presented cost quotes for these services. Council Member Coleman moved to authorize the requested purchases and to authorize Danny McDuffie as the contractor for electrical service at the price quoted. He stated he would like to have an ordinance regulating draft beer in place by July the 5th which is the date the legislation comes into effect.

City Attorney Gray reported on the status of the Crosstimbers Avenue nuisance complaint.

Council Member McCoy inquired about sewer for an area in his district. Mayor Hayes stated he has been discussing the issue with the Water and Sewer Board regarding funding.

Council Member Gillespie stated she could see the progress being made through the efforts of code enforcement.

With due public notice being sent by certified mail to property owners, along with publication in the <u>Geneva County Reaper</u> and posting in public places, a public hearing was held at this time to address abatement for violations of ordinance number 04-2021-02 on the following properties:

106 E Hart Avenue 308 N Morris Street 112 E. Hart Avenue 108 E Hart Avenue

Photos and an inspection sheet were presented as evidence on 106 E Hart Avenue. City Attorney Gray reviewed the Dangerous Building Checklist and items noted which was part of the notice to the property owner(s) and asked Building Inspector Wuest if he completed the form and if that was his signature on the form and if the property was deemed unsafe and a public nuisance. Building Inspector Wuest confirmed completion of the form, verified it was deemed unsafe and a nuisance and verified his signature.

No one from the public was present to speak regarding the property.

Attorney Lee Knowles was present and stated he was filling in for the attorney representing the property owner Mr. Miller. Attorney Knowles stated they would concede the property met the criteria of the ordinance and has already been demolished.

City Attorney Gray presented pictures showing the site after demolition but noted the foundation had not been removed. He inquired of the Code Enforcement Officer and Building Inspector if foundations were required to be removed as part of the abatement and if any other

nuisance remained on the property. Code Enforcement Owens stated items such as an old TV and paint cans needed to be removed.

Attorney Knowles stated they would concede the property at 308 N Morris Street met the criteria of the ordinance and Mr. Miller was in the process of having the house demolished. He requested a 60 day extension to have the house demolished.

Photos and an inspection sheet were presented as evidence on 308 N. Morris Street. Attorney Gray asked the Code Enforcement Officer and Building Inspector if demolition could be completed in the 60 day time frame. They concurred it was possible.

City Attorney Gray asked Attorney Knowles what his client's intensions were regarding 112 E. Hart Avenue. He stated his intentions were to bring the structure into compliance. City Attorney Gray asked if they stipulate that the house meets the criteria of the ordinance as an unsafe structure. Attorney Knowles stated that some items may comply but that his client feels the house can be brought up to code.

Photos and an inspection sheet were presented as evidence on 112 E Hart Avenue. City Attorney Gray reviewed the Dangerous Building Checklist and items noted which was part of the notice to the property owner(s) and asked Building Inspector Wuest if he completed the form and if that was his signature on the form and if the property was deemed unsafe and a public nuisance. Building Inspector Wuest confirmed completion of the form, verified it was deemed unsafe and a nuisance and verified his signature.

City Attorney Gray asked the Building Inspector what would have to be accomplished to bring the house up to code. He stated that he has not been granted access to the inside of the structure to be able to give a detailed list of items needed brought up to code the violations noted were issues visible from outside only and listed several items on the outside of the structure that would need to be brought into compliance.

Council Member Lee asked the property owner what the anticipated time frame would be to bring the property into compliance. The owner was not able to give a proposed date for completion.

City Attorney Gray asked the Building Inspector what would have to be accomplished to bring the house up to code. He stated that he has not been granted access to the inside of the structure to be able to give a detailed list of items needed brought up to code the violations noted

were issues visible from outside only and listed several items on the outside of the structure that would need to be brought into compliance.

City Attorney Gray asked about a time frame for demolition, the owner, Mr. Miller, stated he has already started making repairs but did not have an estimated date of completion.

Attorney Knowles stated that his client would give access to the City to inspect the two properties that Mr. Miller wishes to bring up to code.

No one from the public was present to speak on the property.

City Attorney Gray asked for any further discussion or comments from the owner, public or Council, there being none he stated the public hearing had conclude.

Council Member Lee moved to dispense with the reading and approve the minutes of June 7 and 14, 2022. The motion was seconded by Council Member Bixby and was approved by a six (6) to zero (0) vote with Mayor Hayes abstaining.

City Attorney Gray reported on the status of the ordinance regarding draft beer and the process for adoption and becoming law

Mayor Hayes stated that Items B-Fire Arms Ordinance, J-Zoning and L-Golf Course on the agenda all fit together. City Attorney Gray explained that the items were discussed at the work session. He explained the proposed use of the property did not comply with the permitted uses of the current zoning district. He further explained that the zoning issue could be resolved by the issuance of a conditional use permit. SECTIONS 11-40-30 THROUGH 11-40-36, SECTIONS 11-53B-1 THROUGH 11-53B-16, INCLUSIVE, OF THE CODE OF ALABAMA, AND IN COMPLIANCE WITH ORDINANCE NUMBER 04-2021-02 OF THE CITY OF GENEVA, ALABAMA; AND CALLING FOR THE CITY TO CAUSE SAID DEMOLITION TO BE PERFORMED AND DIRECTING THE CITY ATTORNEY AND THE CITY CLERK TO CAUSE THE COST OF SUCH DEMOLITION TO BE CHARGED AGAINST THE LAND ON WHICH THE BUILDING OR STRUCTURE EXISTS AS A MUNICIPAL LIEN OR CAUSE SUCH COST TO BE RECOVERED IN A SUIT AT LAW AGAINST THE OWNER OR OWNERS IF THE VIOLATION IS NOT VOLUNTARIALY ABATED WITHIN 45 DAYS

The motion was seconded by Council Member Bixby and was approved by a seven (7) to zero (0) vote with Mayor Hayes abstaining.

Mayor Hayes reported on the following:

- 1. Status of the EV Charger installation
- 2. Meeting with a company interested in utilizing the airport
- 3. Completion of the survey for the new City Hall site
- 4. Update on City Hall project
- 5. No bids received for the splash pad
- 6. Functions for the Senior Citizens

City Clerk Johnson reported on additional funding received for the closed-out FEMA grant relating to Hurricane Sally.

City Attorney Gray reported on municipal court.

Police Chief Mock gave an activity report for the month of August. He discussed continued issues with the car line for the elementary school. The issue was to be discussed further at the workshop on the 13th.

Chief Mock informed Council he has an applicant that is a certified officer for the City of Dothan and lives in Geneva that he would like to hire. He stated the officer was just out of the academy and therefore still under contract with the City of Dothan. The cost of the contract buyout versus the cost to send an applicant to the academy was discussed with little in cost difference. Council Member Tidwell moved to authorize the contract buy-out provided there was a contract for repayment to the City if the officer left before two years. The motion was seconded by Council Member Bixby and was approved by a seven (7) to zero (0) vote with Mayor Hayes abstaining.

Street and Sanitation Superintendent Brewer gave an equipment and project report. He informed Council he has completed certification for asbestos inspector. He discussed certification for asbestos remediation and stated this may not be feasible due to all workers needing some form of certification.

Code Enforcement Officer Owens reported on the next list of houses to be served notice under the Dangerous Buildings Ordinance. He reported that he has also completed certification for asbestos inspector.

Fire Chief Latimer reported he has submitted three (3) grant applications for equipment for the department. He reported the generator has been tested and it is not sufficient for supplying power for the cascade system but will run the doors and lights at the station.

Rescue Director Campbell gave a run report.

Mayor Hayes reminded everyone of the 9/11 ceremony.

Council Member Coleman requested a street light on W. Register Avenue between N Wilson Street and Hillcrest Street and a light between 404 and 406 N. Iris Street. He stated he has requests for speed bumps and asked if they could be installed while the contractor was working on the resurfacing project. He inquired if the noise ordinance was applicable to business operations.

Council Member Tidwell reported Wiregrass Hospital will unveil a new unit and encouraged attendance. He expressed appreciation on Council's approval of the paving project. He informed Council he has received numerous positive comments regarding the new soccer complex. Council Member Colman requested a blind spot where you turn on Maple Avenue from Iris Street be addressed.

Council Member Lee recommended a four-way-stop at the intersection of E Promenade and Earl Minshew. He stated he has spoke with the Police Chief regarding the recommendation.

Council Member Tidwell stated there was a rumor that Council has prevented a Super Walmart from coming to Geneva through the years. City Clerk Johnson stated the subject has never been addressed by Council in the 26 years she has been taking minutes for the Council.

Council Member Tidwell moved to adjourn. The motion was seconded by Council Member Bixby and was unanimously approved. Council adjourned at 8:27 p.m.



GENEVA CITY COUNCIL WORK SESSION SEPTEMBER 13, 2022 4:00 P.M.

MINUTES

The Geneva City Council met in work session on September 13, 2022, at 4:00 p.m. in the Council room at City Hall. Members present were Mayor David Hayes and Council Members Rufus Lee., Kim Gillespie, Mike Fountain and Daniel L. Coleman. Council Member Freddy McCoy, Ryan Tidwell and Rich Bixby were absent. Also present were City Clerk/Treasurer Lisa Johnson, City Attorney Jeff Gray, and various department heads and employees.

City Attorney Gray presented four ordinances regulating traffic in various areas of the City for review and comment.

Council discussed building permit fees.

Mayor Hayes reviewed proposed starting salary adjustments, position title changes and job description changes for positions not addressed in March. The following is a recap of proposed starting salary adjustments and position changes:

- 1. Change position title of full-time aide in the Senior Citizens Department to Senior Assistant
- 2. Change position title of Accounting/Office Clerk to Accounting Clerk and increase starting salary to \$18.00 per hour
- 3. Change the position title and job description/requirements of the Personnel/Office Clerk to Payroll/Accounting Clerk and increase the starting salary to \$16.00 per hour
- 4. New starting salaries per hour

Code Enforcement Officer - \$15.00

Administrative Assistant Recreation - \$12.00

Recreation Specialist II - \$15.00

Recreation Specialist I - \$12.00

Library Assistant - \$9.00

Administrative Assistant Police - \$13.00

EOI - \$12.00

EOII - \$14.00

General Laborer - \$10.00

Administrative Assistant City Clerk's Office - \$13.00 with opportunity to advance to \$14.00 per hour once the individual can satisfactory perform all payroll functions as back-up employee.

Mayor Hayes explained that all employees making below the new starting salary will be adjusted to that salary. He stated he then reviewed employees in these positions to see if additional adjustments were needed due to the employee's longevity or skill set. Mayor Hayes stated employees in full-time and permanent part-time positions that had been in their position for six months and were not affected by the starting salary changes or March adjustments were then reviewed for adjustment.

An overview of recommended adjustments being proposed included:

- 1. A minimum of \$.50 for permanent part-time employees working regular shifts
- 2. New salary and additional adjustments averaged \$1.00 per hour with some increases up to \$3.00 per hour for full-time equipment operator, mechanic, foreman, labor, animal control, recreation specialist and clerical in nature classifications
- 3. 5% for salaried employees and department heads
- 4. \$5.00 per call increase for fire runs

A future position for rescue billing/office clerk was discussed.

City Clerk/Treasurer Johnson reviewed a proposed budget which included the projected salary adjustments discussed by the Mayor. She recommended un-earmarking all local revenues except for those pledged to education, phasing out the various bank accounts and having one reserve account.

MINUTES

The Geneva City Council met in regular session on September 19, 2022, at 6:00 p.m. in the Council room at City Hall. Members present were Mayor David Hayes and Council Members Rufus Lee, Freddy McCoy, Rich Bixby, Mike Fountain and Daniel L. Coleman. Council Members Kim Gillespie and Ryan Tidwell, were absent. Also present were City Clerk/Treasurer Lisa Johnson, City Attorney Jeff Gray, and various department heads and employees.

Mayor Hayes called the meeting to order.

Council Member Fountain gave the invocation and Mayor Hayes led the Pledge of Allegiance.

With due public notice being sent by certified mail to property owners, a public hearing was held at this time to address assessment for abatement costs for the following properties:

302 E Promenade Avenue 115 E Hart Avenue

Attorney Gray stated that the structure at 302 E Promenade Avenue had met the criteria as an unsafe structure under Ordinance 04-2021-02. He stated the structure had been abated by the City and the cost of abatement was \$2,154.73.

Attorney Gray stated that the structure at 115 E Hart Avenue had met the criteria as an unsafe structure under Ordinance 04-2021-02. He stated the structure had been abated by the City and the cost of abatement was \$12,427.64.

Attorney Gray asked if any of the property owners or their representative were present to object to or speak regarding the cost as presented. No one was present.

Council Member Fountain moved to dispense with the reading and approve the minutes of September 6, 2022. The motion was seconded by Council Member Lee and was approved by a five (5) to zero (0) vote with Mayor Hayes abstaining.

Mr. Carl Corey appeared before Council to request the street between 101 S. Liveoak to 308 S. Liveoak be closed on October 31st from 5:30 p.m. until 8:00 p.m. for a public trick-or-treat event. Council Member Bixby moved to authorize the closing of the street. The motion was seconded by Council Member Coleman and was approved by a five (5) to zero (0) vote with Mayor Hayes abstaining.

The Mayor declared that without unanimous consent, the motion did not carry.

Council discussed use of Fowler Park by Lewis and Clark Circus.

Council Member Fountain moved to approve amendment to the City's Manning Document that included title and job description changes and new starting salaries. The motion was seconded by Council Member Coleman and was approved by a five (5) to zero (0) vote with Mayor Hayes abstaining.

Council discussed the proposed 22-23 budget. The proposed budget included funding for salary adjustments authorized by the Mayor, for full-time and permanent part-time positions not previously adjusted and the employees had been in the position for a minimum of six months. It also included recommendations discussed at the September 13th workshop for equipment purchases for departments. It was noted that salary adjustments for rescue employees were not discussed at the work shop. It was also discussed that the Recreation Director needs to obtain three bids for the proposed mower and the possibility of obtaining a bigger mower.

Council Member Coleman moved to approve the 22-23 proposed budget as present with the inclusion of a 2% adjustment for full-time rescue employees. The motion was seconded by Council Member Lee and was approved by a five (5) to zero (0) vote with Mayor Hayes abstaining.

Council Member Lee moved to authorize the transfer of ARPA funds to reimburse the General Fund under the standard allowance for revenue loss for government services. The motion was seconded by Council Member Bixby and was approved by a five (5) to zero (0) vote with Mayor Hayes abstaining.

Council Member Bixby moved to approve the July 2022 financials as presented. The motion was seconded by Council Member Fountain and was approved by a five (5) to zero (0) vote with Mayor Hayes abstaining.

Mayor Hayes reported on the following:

- 1. The EV charger has been installed
- 2. Update on City Hall project
- 3. Clean up for homecoming week
- 4. Long range planning for road maintenance

Mayor Hayes informed Council there may be some additional funds left in the paving project and asked Council if funds were available if they had recommendation for additional paving. Council Member Fountain recommended Earl Minshew Street to Promenade Avenue.

City Clerk Johnson reported on additional funding received for the closed-out FEMA grant relating to Hurricane Sally.

City Attorney Gray reported on municipal court and upcoming judicial conference.

Code Enforcement Officer Owens reported on the 20-day timeframe for owners to correct violations will be up next week on three properties discussed last meeting.

Fire Chief Latimer reported he should know in the next couple of weeks if the grant application for the jaws of life was approved. He also reported on educational training for the local elementary school being taught by the department.

Police Chief Mock presented a budget request for the animal control department with new fencing in the amount of \$4,250.00, a new tranquilizer gun in the amount of \$425.95 and aircondition units totaling \$800. Council discussed a split a/c unit. Council Member Bixby moved to approve the request expenditures for the fencing and gun and up to \$2,500.00 for a split a/c unit as part of the new 22-23 budget. The motion was seconded by Council Member Fountain and was approved by a five (5) to zero (0) vote with Mayor Hayes abstaining.

Chief Mock also discussed plans for security for homecoming and a meeting by the Chamber where school safety will be discussed with various law enforcement agencies participating.

Street and Sanitation Superintendent Brewer gave an equipment and project report.

Senior Director Owens reported on center functions and the need for a new refrigerator. Council Member Bixby moved to authorize the purchase of a new refrigerator if one located at the community center is not sufficient in size to be transferred. The motion was seconded by Council Member Lee and was approved by a five (5) to zero (0) vote with Mayor Hayes abstaining.

Pastor and School Board Member Russell Clausell was present and invited Council to a tailgate event at the school and a Untied Way meeting.

Council Member Coleman asked if 205 N. Cherokee is in compliance with ordinances. He also reported someone tried to steal a prefab shed from his property over the weekend.

Council Member Bixby expressed appreciation for work on Lakewood Loop.

Council Member Fountain reported he is receiving complaints regarding speeding on Liveoak Street.

Council Member Tidwell moved to adjourn. The motion was seconded by Council Member Bixby and was unanimously approved. Council adjourned at 7:23 p.m.
